Cultural Funding by Government—2023–24


Overview

In 2023–24, the estimate of total expenditure on cultural activities, funded by the three tiers of government, was **\$8,607.9m**.

The \$8,607.9m in funding for cultural activities from the three tiers of government comprised:

- \$3,113.6m (36% of total) from the Australian Government
- \$3,336.5m (39%) from State and territory governments
- \$2,157.8m (25%) from local governments.

Figure 1. Cultural expenditure (recurrent and capital), by level of government



Total expenditure rose 3% (or \$290.4m) from 2021–22. Expenditure increased for State and territory government and Local government (<1% and \uparrow 18% respectively) but decreased for Australian Government (\downarrow 2%).¹

Total recurrent expenditure rose 2% (or \$141.1m) to \$7,016.5m and accounted for 82% of total funded cultural expenditure. Australian Government recurrent expenditure was \$2,768.5m, the highest dollar amount of the three levels of government and represented 39% of total recurrent expenditure. Total capital expenditure by all levels of government was \$1,591.4m in 2023–24, an increase of 10% (or \$149.3m) from 2021–22.

Most capital expenditure was funded by State and territory government with \$916.7m (58% of total capital expenditure).

The Australian Government allocated 72% of the total funded cultural expenditure to *Arts* activities and 28% to *Heritage* activities. The five categories with the highest expenditure by the Australian Government in 2023–24 was:

- 1. Radio and television services—\$1,598.3m
- 2. Other museums and cultural heritage—\$438.9m
- 3. *Archives*—\$156.2m
- 4. Film and video production and distribution—\$149.8m
- 5. *Art museums*—\$147.0m.

The five categories with the highest expenditure by State and territory government in 2023–24 was:

- 1. Other museums and cultural heritage —\$780.8m
- 2. *Performing arts venues*—\$477.2m
- 3. *Libraries*—\$471.6m
- 4. *Art museums*—\$329.1m
- 5. Film and video production and distribution—\$228.6m.

The jurisdiction with the highest expenditure by Local government in 2023–24 was Victoria (\$656.0m), followed by New South Wales (\$650.5m), and the highest per person funding by Local government was South Australia (\$114.89).

The estimate of per person cultural funding by the three tiers of government was \$319.43 with:

- Australian Government—\$115.54
- State and territory government—\$123.81
- Local government—\$80.07.
