Driven by this principle, and guided by Minderoo Foundation's values, we work collaboratively with high-quality organisations and artists to leverage creativity and artistic excellence to deliver meaningful impact and social change in our communities through co-created partnerships and strategic arts projects. We focus primarily on our home state of Western Australia but engage nationally and globally.

We believe collaboration is key. Through our partnerships, projects and advocacy, we work closely with those who align with our values to co-create opportunities that have long-term impacts for the sector and nation as a whole.

RESPONSES TO NATIONAL CULTURAL POLICY CONSULTATION

Introduction

As a long-term supporter and partner of the arts and cultural industries, Minderoo Foundation welcomes the Federal Government's commitment to establish a National Cultural Policy.

Support for and investment in Australia's national cultural and creative industries is fundamental to securing our place in the world, by the telling of diverse Australian stories, giving a platform to creative expression, and promoting inclusiveness. When properly supported and leveraged, the industry delivers a social and economic dividend that goes beyond the arts. It supports community wellbeing and provides value to educational institutions and the health sector, and increasingly works in collaboration with emerging technology and science.

Developing a National Cultural Policy is, however, just the beginning. It provides a strong foundation for great action and possibility. Minderoo Foundation sees this policy development as the start of a more robust and coordinated approach to arts investment and, through our philanthropic endeavours, we look forward to working collaboratively with government as it embarks on the implementation phase to strengthen Australia's cultural life and creative industries.

The value of arts and culture

The evidence is clear; prioritising arts and culture has broad ranging economic, social, institutional and community benefits. Arts and culture are inextricably linked to our daily lives and play a central role in improving the quality and richness of life at an individual and societal level.

Participating in arts and culture delivers positive health and wellbeing impact. A New Approach has produced evidence¹ that shows engagement in cultural activities enhances social inclusion; reduces loneliness; increases confidence; and improves feelings of self-worth. These outcomes, in turn, have a direct and positive impact on physical and mental health. Arts and cultural tools have also been

used successfully to improve outcomes in terms of both prevention and treatment of physical illnesses and diseases.

Consuming and participating in arts and cultural activities helps us create ideas, develop curiosity, understand and embrace different perspectives, and build a sense of belonging². Childhood interactions with arts and culture can influence creative thinking that continues through to adulthood, as well as equipping people to develop innovative outcomes in the workplace and in society more broadly.

As Australia starts to recover from the impacts of COVID-19, support for creativity and a healthy domestic arts industry is crucial. With the World Economic Forum noting "Creativity, originality and initiative" as one of the Top 10 skills that will be required by 2025³, we should not underestimate the economic benefits and value that a strong and sustainable sector delivers for communities across Australia, and the positive flow-on effect.

Minderoo Foundation champions the social and economic value of the arts and we see ourselves as strong collaborators with the Commonwealth in delivering meaningful and long-term outcomes. As a coalition partner of A New Approach, and research partners with UWA's *Good Arts, Good Mental Health* project, we are funding research that has delivered evidence that will help the sector expand and thrive.

How Minderoo Foundation celebrates Australia's strong, diverse, and inclusive culture

We are pleased to note that our focus aligns with the five pillars of the National Cultural Policy and that Minderoo Foundation's long-standing support for arts and culture complements the government's articulated priority policy areas.

Reaching the Audience – increasing access

With ~30% of Australians living outside capital cities, and WA regional communities experiencing more barriers to arts participation that those in metropolitan areas, we believe that increasing audience access is a significant policy pillar. Our philanthropic work aims to build connected and creative regional communities through our investments and collaborations.

Opportunities to access, use, enjoy, connect with arts and culture are inclusive. If we want strong, healthy, and resilient communities, arts and culture must connect not just in capital cities, but also in our regional and remote communities – including by increased investment in cultural infrastructure projects (such as live music venues, arts centres, museums), support for regional programs, festivals, and tours, securing stable and reliable high-speed broadband to increase accessibility, and promoting engagement in the arts at a grassroots level.

A Place for Every Story - Youth arts

We are developing a rigorous new strategy to facilitate targeted investment for children's access to the arts.

Through the work of another Minderoo Foundation initiative, Thrive By Five⁴, we are fortunate to have insights into the critical brain science behind early childhood development, lifelong learning, and wellbeing. Thrive By Five has identified that play-based learning and creativity help shape thinking and emotional patterns for life and influence learning, relationships, and resilience.

This evidence led us to expand our reach to youth arts practitioners and organisations, which has begun with:

- the Children's Ballet at West Australian Ballet
- Tura New Music's music program in Fitzroy Crossing
- Yvan Karlsson's non-verbal puppetry work, *The Lion Under the Sea*, by Monkey Brain Theatre

In order to create opportunities for all Australians to participate in, and contribute to arts and culture we are supportive of targeted investments for children and young people across Australia.

Centrality of the Artists - Arts training and skill development opportunities

We invest heavily in support for our artistic workers, providing the training and skill development that a thriving workforce requires. We look for gaps that complement existing government support.

This includes:

- an international program of excellence with the Western Australian Academy of Performing Arts (WAAPA), providing support to bring acclaimed visiting artists to WAAPA
- identification and support for key career pathways with the Perth Institute of Contemporary Arts, The Blue Room Theatre and Fremantle Press
- artist awards with Sculpture by the Sea and the Lester Prize
- visiting artist training opportunities with the WA Youth Jazz Orchestra

We collaborate with our colleagues in Minderoo Foundation's Generation One initiative⁵ to enhance employment opportunities in the arts for First Nation Australians.

We also directly support artists through our annual Minderoo Foundation Artist Fund. Designed to support mid-career artists we provide grants, residencies, and an annual \$50,000 award for artists to explore, develop, create, and present new work in Western Australia. This program will be expanding nationally and internationally in 2023.

Strong Institutions

Strong institutions are the bedrock of the sector. Our capacity initiatives are helping to support the most critical WA institutions. Minderoo Foundation is:

- a founding partner of Black Swan's Future Fund
- a Principal partner for *Illuminate* at the West Australian Museum
- a Principal partner for Perth Symphony Orchestra's annual program
- a capacity partner for The Last Great Hunt's Creative Development Program

and we collaborate closely with organisations such as Fremantle Biennale to not only support a major innovative work like the drone show *Moombaki*, but also establish a long-term, self-sustaining social enterprise that expands the reach, revenue, and impact of these drone projects.

Our capacity- style funding and commitment has helped unlock a great deal of other support, including through the Australian Government's RISE fund⁶.

Arts as a tool for change

Minderoo Foundation seeks to harness the power of arts to change hearts and minds and compel audiences to action through our Arts for Change initiatives. We are backing projects across all art forms that discuss climate change, the fragility of our environment, the eradication of modern slavery and more.

Launched in 2021, Minderoo Pictures is a \$10 million social impact film enterprise that is actively backing screen projects that make a difference.

Working with Australian film teams as well as global filmmakers, we have already invested in projects focused on plastics and human health, early childhood practices in Indigenous communities, the Western Desert Art Movement and ocean health and preservation. We are committed to strengthening our local screen industry through development programs for practitioners, working with Documentary Foundation and Screen West.

The role of Minderoo Foundation and philanthropy – the importance of cultural giving

Good cultural policy is for everyone. A culturally confident nation touches the lives of all and provides benefits across communities. However, ambitious possibilities can't be delivered in isolation, and coordinated efforts are needed across all levels of government and society.

Minderoo Foundation firmly believes that Australia's national philanthropic giving must increase and that the current administrative impediments with the deductible gift recipient (DGR) scheme are standing in the way of greater charitable endeavours. Minderoo encourages the government to look at reforms to address this issue and mechanisms to further opportunities to promote and support cultural philanthropy at every level.

Minderoo Foundation sees its role as a convenor, collaborator, supporter, investor, and partner, working with the arts industry and with government. We will continue to advocate for the importance and impact of giving to and supporting the arts.

We encourage Federal Government initiatives that provide approaches to generate further support, philanthropy and investment into the arts and we will continue to look for ways in which Minderoo
